



## Year 5-12 2024 General Levy

Dear Parent/Caregiver,

North Lakes State College operates a Student Resource Scheme (SRS) to supply resources that are not funded through Government funding (e.g., textbooks, online subscriptions, consumables etc). More information regarding what is included in the SRS fees can be found on our [College website](#).

Our records show that you have either elected not to join the SRS or have not completed an SRS Participation Agreement Form (SRS PAF) indicating your preference, as such, you will be invoiced for the General Levy fee unless you advise us by the due date. If you wish to change your preference and participate in the Student Resource Scheme, please complete a new SRS Participation Agreement Form (one per student) and return to the College by Wednesday 24 January 2024. The cost of the 2024 General Levy is between \$30 - \$70 (depending on the year level), which covers the student diary, ID card, teacher printed worksheets and/or Writers Toolbox online subscription. All other resources, online subscriptions, textbooks and consumables are to be supplied by the start of the school year. **The General Levy fee is due by Friday 26 January 2024.**

For your child to be eligible for extra curricular activities, e.g., interschool sports, dances, formals, senior jersey, Year 6 Shirt etc. the General Levy fee must be paid in full and you must provide materials required for learning, including online subscriptions, textbooks and other consumable resources.

The table below shows a breakdown of the costs of mandatory resources and whether they are included in the General Levy, plus the cost to families to purchase required resources if they are not included.
